El Dorado County – Incorporated February 18, 1800

### **Re: County Seat of El Dorado County**

Page 189 – Order of Election for May 17, 1856

Page 201 – Result of Election: Coloma for County Seat 7413  
Placerville for County Seat 5895

County Seat at **Coloma** from 1850 to April 1, 1857

### **Volume – Minute Book “B” ( 1857)**

- Page 151 November 2, 1857: “met in Courthouse in Placerville”
- Page 78 Examine location for courthouse at Stoney Point on Main Street (be location?)
- Page 73 Board members authorized to move records from Coloma to Placerville
- Page 69 – Placerville to be County Seat on April 1, 1857 by “An Act to Establish the County Seat of El Dorado County (evidently an Act of the State Legislature)
